Indicated film thickness, wet: 50 micron [2 mils]

APPLICATION CONDITIONS:	<p>New wood except teak and vacuum impregnated wood: Saturate the dry, clean surface with suitable wood preservative, allow to dry. Apply two coats of the product on internal areas and three coats on weather exposed areas.</p> <p>New teak and vacuum impregnated wood: Apply two coats of the product. The surface must be completely clean and dry. Teak is preferably cleaned with:HEMPEL'S TEAK CLEANING POWDER 67543.</p> <p>Previously treated wood: Remove all contaminants with a suitable detergent. Remove all loose material, remove dust by vacuum cleaning Treat any bare spots with suitable wood preservative (not teak). Apply 1-2 coats of the product. The product should preferably be thinned 1:1 with suitable wood preservative to keep the shade.</p>
SUBSEQUENT COAT:	None.
REMARKS:	
Application(s)	<p>The surface must be completely clean and dry. Do not apply under humid conditions or at temperatures below: 5°C/41°F.</p> <p>The moisture content in the wood should not exceed: 16%. In confined spaces provide adequate ventilation during application and drying.</p> <p>The practical spreading rate is:10-20m²/l/408-846sq.ft/US gallons for smooth surfaces. On rough or absorbing surfaces the spreading rate will be lower, typically:5-10 m²/l/204-408 sq.ft./US gallons.</p> <p>As autoignition of rags impregnated with the product is possible, they should be safely disposed of after use.</p> <p>Avoid cleaning or grinding of the surface with steel wool or similar as this might cause rust stains.</p>
